The Issuer continues to facilitate website orders for plant-based prepared meals and plants throughout Canada and the United States. The Issuer continues to expand its delivery capabilities to Central and Eastern Canada.

The Issuer facilitates website order for plants throughout Canada, the United States, UK and Germany.

The Issuer wholesales food and beverages to Liv Marketplace.

On March 1, 2021, the Issuer announced its Q3 financial results with revenue increasing 298% from the prior quarter.

On March 11, 2021, the Issuer filed a final short-form prospectus in connection with its public offering. The Issuer offered units (the "Units") at a price of \$1.05 per Unit for minimum gross proceeds of \$10 million and maximum gross proceeds of \$20 million (the "Offering"). Each Unit was composed of one (1) common share and one (1) common share purchase warrant at an exercise price of \$1.25 per share. The Issuer granted a 15% over-allotment option in connection with the Offering.

On March 22, 2021, the Issuer completed the closing of the over-subscribed Offering for aggregate gross of \$20,057,903.25.

On March 24, 2021, the Issuer announced a partnership with Chef Anne Thornton to create the new PlantXReset Program.

On March 29, 2021, the Issuer announced new green packaging and sustainability initiatives to help reduce the Issuer's carbon footprint.
